Dr. Marcella Colbert, M.B., MRCPsych, DPM, is Director of the Respect Life Office of the Archdiocese of Galveston-Houston since 1973. She took her degrees in Medicine and Psychiatry at University College Dublin in 1968 and 1972, and she became a member of the Royal College of Psychiatrists in 1973. She has studied at the Tavistock Clinic of Humane Relations (London) and at Cambridge University. She has extensive experience as a clinical psychiatrist and as a teacher of clinical psychiatry to undergraduate and post graduate physicians. Active since 1969 in pro-life initiatives, she has made numerous presentations at pro-life conferences. She lives in Houston, Texas with her six children.

He has also served as counsel to the Secretary of Education's Commission on Opportunity in Athletics. Mr. Duncan has published numerous articles in legal journals and other publications on issues related to family law and policy and the constitution.

Prof. Damian P. Fedoryka obtained his graduate degrees from Fordham University and the University of Salzburg after receiving an undergraduate education at the University of Louvain. He is currently an associate professor of philosophy at Loyola Marymount University, Los Angeles.

Currently she is the Executive Director of the Natural Family Planning Center of Washington, D.C., Inc. and the Teen STAR Program (*Sexuality Teaching in the context of Adult Responsibility*), an international pro-active sexuality education program for teens that currently operates in 27 countries. She has taught at Washington University, St. Louis University, and George Washington University Medical Center. She has published 60 scientific articles, and 42 “popular” articles, many concerned with natural family planning and the Teen STAR program. She is a Fellow of the American College of Obstetricians and Gynecologists and a Diplomate of the American Board of Obstetrics and Gynecology.

He taught at Case Western Reserve University School of Law and the University of Detroit Mercy School of Law before joining the Ave Maria faculty. His courses have included Constitutional Law and First Amendment, in addition to Antitrust, Civil Procedure, Conflict of Laws and Federal Jurisdiction. He has published extensively on constitutional law in the law reviews of Catholic University, Case Western Reserve University, Notre Dame University, and Washington and Lee University. He is a co-editor of *St. Thomas Aquinas and Natural Law: Contemporary Philosophical and Theological Perspectives* (Catholic Univ. of America Press) and of *Catholic Social Thought, Social Science, and Social Policy: An Encyclopedia* (Scarecrow Press, forthcoming). Professor Myers is the President of University Faculty for Life and the Executive Secretary of the Society of Catholic Social Scientists. Professor Myers is married to Mollie Murphy, who is also a Professor of Law at Ave Maria School of Law. Prof. R. Mary Hayden Lemmons is an Associate Professor of Philosophy and Catholic Studies at the University of St. Thomas in St. Paul, Minnesota.
